## **Job Purpose**

You will be responsible for delivering a range of specialist group exercise classes for adults with long-term health conditions, disabilities or other needs.

This role requires a motivated and passionate fitness instructor with previous experience in planning, implementing and evaluating physical activity interventions.

### **Service Area**

The ER Instructor will be part of the Health & Wellbeing team, working from our Sports and Community Centre in Redhill. The role reports to the Exercise Referral Coordinator.

#### **Job Profile**

#### Main responsibilities

- 1. To deliver a range of specialist group exercise classes for specific long term health conditions such as Stroke Rehabilitation, Cardiac Rehabilitation, MS, COPD, Diabetes, Seated Exercise and Falls Prevention.
- 2. To arrange and carry out consultations and create personal progressive programmes of exercise to meet the health needs of the individual.
- 3. To obtain additional medical or other additional information when risk stratification requirements deem it necessary.
- 4. To be responsible for the health and safety of clients attending the Exercise Referral scheme and to ensure staff, volunteers and clients are not exposed to undue risk.
- 5. To support volunteers who assist with exercise referral classes.
- 6. To advise the Exercise Referral Coordinator on issues relating to referrals, classes, the wellbeing of clients and new inclusive fitness equipment.
- 7. To ensure that relevant safeguarding policy and procedures are followed to protect adults that are at risk.

- 8. To attend any relevant training courses that are required to meet the needs of the service.
- 9. Attend YMCA East Surrey staff meetings, training and staff development events, as appropriate, to ensure continuous professional competence and development
- 10. Undertake any other duties and responsibilities reasonably requested by your line manager
