### Job Purpose:

To actively engage with learners on a day-to-day basis to promote positive behaviours, physical wellbeing, and inclusion. Responsible for delivering a range of enrichment activities and events to enhance the learner experience with a focus on wellbeing, personal development and inclusion.

### Duties Specific to the Post:

- Devise, plan and implement a calendar of engaging enrichment and sports activities, ensuring a positive and well-rounded experience at the College that supports behaviour, wellbeing and development.
- Lead and coach learners in a variety of sports and physical activities suited to different ability levels (Sport and Non-Sporting)
- Develop a friendly but efficient working relationship with learners, promoting attendance and engagement.
- Actively liaise with learners around the campus to promote positive behaviours and participation.
- Support and attend Learner Parliament and Learner Union meetings.
- Oversee and support the day-to-day supervision and safe use of the areas.
- Organise and supervise fixtures and internal sporting events, which may require occasional evening work.
- Promote inclusive use of college spaces for recreational and wellbeing purposes.
- Ensure the safety of all users during enrichment and sports activities and respond appropriately to first aid needs.
- Maintain cleanliness and organisation in sports and fitness areas.
- Manage inventory, setup, and maintenance of sports and enrichment equipment.
- Provide input into the College Tutorial Programme when requested.

- Liaise with teaching staff and tutors regarding the enrichment programme and organise extra sessions as necessary.
- Ensure compliance with health and safety, safeguarding, equality, and data protection.
- Contribute to the wider cultural, personal development, and employability programme through physical activity and health promotion.

**General:**

- Participate in open evenings and recruitment activities to ensure that potential applicants and students receive accurate information and guidance.
- Ensure all data is handled in line with General Data Protection Regulations.
- Taking responsibility for health and safety, equality & diversity, copyright and data protection within the scope of the post.
- Take appropriate responsibility to provide a secure, safe and friendly learning environment including implementation of the College's Health and Safety Policy.
- Committed to Safeguarding and promoting the welfare of children and vulnerable adults, ensuring that this commitment is demonstrated in all aspects of the role as appropriate.
